Members are eligible to vote (one per member) at the Annual Convention, to nominate to Futurities, Colorado Stallion Breeders Races, Mile Hi Select Sale, and to accumulate points toward year-end awards in the Show & Performance, Youth and the Race Divisions. RMQHA membership expires December 31 of each year. Memberships also include the Rocky Mountain Quarter Horse monthly magazine unless you are purchasing a Lifetime Membership, then you must subscribe to the magazine on a yearly basis..

MEMBERSHIP Descriptions: (See AQHA and RMQHA rules for official definitions).

YOUTH: Individuals 18 years & under are eligible for RMQHYA approved shows and year-end awards **only** with the horse owned by Youth or immediate family.

YOUTH/OPEN: Individuals 18 years & under are eligible for RMQHYA approved shows and year-end awards, as well as Open division. The youth may show and accumulate points for a horse owned by immediate family or a non-family member provided the owner is also a full RMQHA member.

AMATEUR: Individuals that own their own horse (or the immediate family owns) and have never received remuneration for services consisting of training, instructing, riding, showing, etc for at least five years prior to application are eligible for approved shows and year-end awards.

NOVICE: Exhibitors can not have earned 25 or more halter or performance points in any AQHA Open, Youth or Amateur Divisions skill set or combination thereof, or more than 25 Novice Points combination or skill set thereof. See AQHA Handbook for complete rules.

OPEN: Membership in open division entitles the person and the horse entered to participate in approved shows and races and accumulate individual points towards year-end awards. Both the rider and the horse owner must hold memberships with the RMQHA.

OPEN CORPORATE, PARTNERSHIP, RANCH: Include syndicates, and other legal entities that own, show, or race a horse which becomes eligible to participate in approved shows &/or races and accumulate points for year end awards.

FAMILY: A membership in the names of a family who desires to be involved in Rocky Mountain Quarter Horse Assn. for recreational riding.

**In accordance with AQHA rules, every membership above is entitled to all benefits of the RMQHA except Youth which do not have the privilege to vote or hold an RMQHA office.

** Every separate exhibitor and horse ownership that will accumulate points must have a RMQHA membership!!! **

Example:

JO SMOOTH is owned by AQHA # 1234567 – Jane & Tom Smith Is shown Amateur by AQHA # 7654321 – Jane Smith

Is shown Open by AQHA # 3214567 – Tom Smith

With Jane having a RMQHA member and Tom having a RMQHA membership, the joint membership will be given without purchase. If Tom were not an individual member, a second one in the name of Jane & Tom would have to be purchased for open points to count.

Please notify the office if a joint membership is needed with the purchase of individual memberships!!!
