BUYERS AND CONSIGNORS TAKE NOTICE. THIS SALE IS CONDUCTED IN ACCORDANCE WITH AND ALL ACTS OF INTERESTED PARTIES AND/OR CLAIMS BY THEM SHALL BE GOVERNED BY THE FOLLOWING CONDITIONS OF SALE. BUYERS AND CONSIGNORS ARE BOUND BY THESE CONDITIONS OF SALE WHETHER YOU READ THEM OR NOT.

#### FIRST - APPLICABLE LAW:

ALL HORSES IN THIS SALE ARE OFFERED ACCORDING TO THE LAWS OF THE STATE WHEREIN THE SALE IS CONDUCTED. THE RIGHT TO BID, AS PROVIDED UNDER LAW, IS RESERVED FOR ALL CONSIGNORS UNLESS OTHEWISE ANNOUNCED.

SECOND: EXCEPT AS SET OUT HEREIN, THERE IS NO REPRESENTATION, WARRANTY OR CONDITION, EXPRESS OR IMPLIED, BY THE ROCKY MOUNTAIN PAINT HORSE ASSOCIATION SALE MANAGEMENT ("RMPHA"), ROCKY MOUNTAIN QUARTER HORSE ASSOCIATION ("RMQHA"), AUCTIONEER, OWNER OR CONSIGNOR PURSUANT TO THE SALE OF GOODS ACT OR OTHERWISE. WITHOUT LIMITATION TO THE FOREGOING, THERE IS NOT REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, BY THE RMPHA/RMQHA, AUCTIONEER, OWNER, OR CONSIGNOR AS TO SOUNDNESS, MERCHANTABILITY, OR FITNESS FOR ANY PARTICULAR PURPOSE OF ANY HORSE OFFERED IN THIS SALE. THIRD - BIDDING PROCEDURE: THE PERSON MAKING THE HIGHEST BID RECOGNIZED BY THE AUCTIONEER SHALL BE THE BUYER. IF ANY PERSON SHALL PURCHASE A HORSE AND FAIL TO PAY FOR IT WITHIN THE TERMS AS SET FORTH IN THE FIFTH AND SIXTH CONDITIONS ABOVE, NOTHING CONTAINED HEREIN SHALL PREVENT THE RMPHA/RMQHA OR CONSIGNOR FROM FILING SUIT TO COMPEL SUCH PERSON TO PAY FOR IT. THE RMPHA OR CONSIGNOR SHALL ALSO HAVE THE OPTION TO RETRIEVE THE HORSE FROM BUYER, AT BUYERS EXPENSE, AND RESELL AT PUBLIC OR PRIVATE SALE WITHOUT NOTICE. COSTS, INCLUDING ATTORNEYS FEES. OF SUCH SUIT OR RESALE SHALL BE BORNE BY BUYER. SHOULD SUCH RESALE FAIL TO SATISY THE DEFAULTING BUYERS ACCOUNT IN FULL, DEFAULTER SHALL BE LIABLE FOR THE AMOUNT OWING, INCLUDING ALL COSTS OF COLLECTION AND ATTORNEYS FEES. EIGHTH - WARRANTIES AS TO SOUNDNESS: UNLESS EXPRESSLY ANNOUNCED FROM THE AUCTION BOX OR BY OFFICIAL PUBLICATION OF THE RMPHA/RMQHA, THERE IS NO WARRANTY OR GUARANTEE OF ANY KIND AS TO THE SOUNDNESS OR CONDITION OR OTHER QUALITY OF ANY HORSE SOLD IN THIS SALE. ELEVENTH - ARBITRATION: 1) ANY CONTROVERSY ARISING OUT OF A CLAIM AS TO SOUNDNESS OR BREEDING ABILITY SHALL BE SETTLED BY ARBITRATION BETWEEN THE BUYER AND THE CONSIGNOR PURSUANT TO THE FOLLOWING PROCEDURE. UPON THE RMPHA/RMQHA'S DETERMINATION THAT A CLAIM UNDER SUCH CONDITIONS OF SALE HAS BEEN TIMELY AND PROPERLY PRESENTED BY THE BUYER PURSUANT TO THESE CONDITIONS OF SALE AND UPON NOTICE FROM THE RMPHA/RMQHA, THE BUYER AND THE CONSIGNOR SHALL EACH SELECT A LICENCED VETERINARIAN ACCEPTABLE TO THE RMPHA/RMQHA. IF SUCH VETERINARIANS FAIL TO AGREE PROMPTLY AS TO THE VALIDITY OF THE CLAIM, THEY OR THE BUYER AND THE CONSIGNOR INVOLVED IN THE CONTROVERSY, SHALL AGREE UPON A THIRD LICENSED VETERNARIAN. IF TWO SUCH VETERINARIANS OR THE BUYER AND THE CONSIGNOR ARE UNABLE TO AGREE PROMPTLY UPON THE THIRD VETERINARIAN, THE RMPHA/RMQHA SHALL APPOINT THE THIRD VETERINARIAN. THE THIRD VETERINARIAN'S FEE, EXPENSES, COSTS, AND SALES COMMISSION SHALL BE PAID BY THE PARTY WHOSE PROPERTY THE HORSE IS DETERMINED TO BE. THE PANEL OF THREE VETERINARIANS SHALL CONDUCT ANY TESTS, INVESTIGATION OR EXAMINATIONS DEEMED NECESSARY, AND MAY, IN THEIR DISCRETION, CONDUCT A HEARING BY NOTIFYING THE RMPHA/RMQHA TO ARRANGE FOR THE HEARING AND SHALL, BY MAJORITY VOTE, DETERMINE THE VALIDITY OF THE CLAIM. THE RMPHA/RMQHA SHALL DETERMINE THE AMOUNT OF REIMBURSEMENT DUE TO A BUYER WHOSE CLAIM IS DETERMINED TO BE VALID AND MAY, IN ITS SOLE DESCRETION, CONDUCT A HEARING TO AID IN MAKING SUCH A DETERMINATION, AND SUCH DETERMINATION SHALL BE INCORPORATED IN THE AWARD.

2) ANY OTHER CONTROVERSY BETWEEN OR AMONG THE BUYER, CONSIGNOR, AND THE RMPHA/RMQHA, OR ANY TWO OF THEM, ARISING OUT OF A CLAIM MADE UNDER THESE CONDITOINS OF SALE OR CONSIGNOR'S CONTRACT, MAY BE SETTLED BY ARBITRATION AMONG THE PARTIES, AT RMPHA/RMQHA'S SOLE OPTION, IN ACCORDANCE WITH THE COMMERCIAL ARBITRATION RULES OF THE AMERICAN ARBITRATION ASSOCIATION.

3) ARIBRATION UNDER 1 OR 2 ABOVE SHALL TAKE PLACE IN THE STATE OF COLORADO IN THE CITY AS DESIGNATED BY THE RMPHA/RMQHA. JUDGEMENT UPON ANY AWARD RENDERED BY THE ARBITRATOR(S) MAY BE ENTERED IN ANY COURT HAVING JURISDICTION THEREOF. THE RMPHA/RMQHA WILL BE ENTITLED TO REIMBURSEMENT FROM THE PARTY WHOSE PROPERTY THE HORSE IS DETERMINED TO BE FOR REASONABLE ATTORNEY'S FEES AND OTHER COSTS INCURRED BY THE RMPHA/RMQHA IN THE ARBITRATION AND ANY RELATED COURT PROCEEDINGS. ANY SUCH CONTROVERSY, CLAIM, DEFENSE OR DISPUTE SHALL NOT IN ANY WAY AFFECT THE ABSOLUTE OBLIGATION OF THE BUYER TO PAY THE FULL PURCHASE PRICE TO THE RMPHARMQHA OR THE OBLIGATION OF THE CONSIGNOR TO PAY THE COMMISSION AS IF SOLD.

TWELFTH - COLLATERAL AGREEMENTS: -THE RMPHA/RMQHA SHALL NOT BE BOUND BY ANY ORAL OR WRITTEN AGREEMENT BETWEEN THE BUYER AND THE CONSIGNOR VARYING FROM THESE CONDITIONS OF SALE (UNLESS AGREED TO BY THE RMPHA/RMQHA), AND ANY CONTROVERSY OR CLAIM BETWEEN THE BUYER AND CONSIGNOR ARISING OUT OF SUCH AGREEMENT SHALL BE A MATTER FOR THEIR RESOLUTION BY SETTLEMENT, LITIGATION, ARBITRATION, OR OTHERWISE AS THEY DETERMINE WITHOUT ANY PARTICIPATION BY RMPHA/RMQHA.

THIRTEENTH- AUTHORIZED AGENTS: -PERSONS ACTING AS AUTHORIZED AGENTS FOR CONSIGNORS MUST FILE NOTARIZED LETTERS OF AUTHORIZATION FROM THE CONSIGNOR STATING THE AGENT IS ACTING ON THEIR BEHALF AND THAT SAID CONSIGNOR WILL BE RESPONSIBLE FOR THE AGENT'S SALES OR PURCHASES ON HIS/HER BEHALF. THESE LETTERS MUST BE ON FILE WITH THE SALES OFFICE PRIOR TO THE START OF THE SALE.

FOURTEENTH - REGRISTRATION CERTIFICATES: RMPHA:- APHA WILL PROCESS REGISTRATION PAPERS FOR TRANSFERS OF OWNERSHIP AFTER THE PUCHASE PRICE HAS BEEN PAID IN FULL. RMQHA: RMQHA WILL MAIL ALL REGISTRATION PAPERS DIRECTLLY TO AQHA 20 BANKING DAYS AFTER THE SALE UNLESS PAID BY CASH OR CERTIFIED FUNDS IN WHICH CASE THEY WILL BE SENT IN 72 HOURS. THE RMPHA/RMQHA ACTS SIMPLY AS AGENTS AND WILL ENDEAVOR AT ALL TIMES TO PROTECT THE INTERESTS OF BOTH BUYER AND CONSIGNOR.
