I understand to be eligible for awards from the Colorado Horse Breeders and Owners Awards and Supplemental Purse Funds that I must be a RMQHA member at the time foal earns points and monetary awards are actually distributed (2 years). *I understand that the person eligible for the awards is the owner of the mare at time of foaling per AQHA records and not at the time of breeding.*

By signing this form, you agree to hold the Association harmless if you have misrepresented any information concerning the eligibility of the horse and the Association has relied to its detriment upon that information. If the mare is found to be falsely enrolled in the Colorado Broodmare program, Colorado Bred status will be revoked. The mare will be declared ineligible and awards or monies earned will be forfeited as well as any future Colorado Broodmare/Breeders awards or monies. The mare's progeny that is unraced will also be declared ineligible for enrollment in the Colorado bred program.

ENROLLMENT FEE/RULES FOR ELIGIBLE MARE

One time Registration Fee per owner. Mare must be re-enrolled with each change of ownership.

Must be an RMQHA member to enroll. Active broodmare reports required annually.

Enrollment fee due from January 1 to December 31 in year prior to foaling - \$35.00/ Current RMQHA member

Late enrollment fee due - After January 1 of current year but prior to foaling - \$100.00/ Current RMQHA member
