The stallion will be declared ineligible and awards or monies earned will be forfeited as well as for any future Colorado Stallion awards or monies.

**ENROLLMENT FEE/RULES FOR ELIGIBLE STALLION - effective 1-1-2022**

Stallion must be enrolled by June 1st of the initial year of standing at stud

If stallion leaves the State of Colorado to stand for breeding in another state or country, he must be re-enrolled if he returns to the State of Colorado for breeding purposes. Report requested if stallion leaves the State.

One-time Registration Fee per owner. Stallion must be re-enrolled with each change of ownership.

Flat Transfer Fee - \$50.00 for each ownership change

**Must be an RMQHA member to enroll. Stallion reports required annually.**

Enrollment fee due by June 1st enrollment deadline - \$100.00/ Current RMQHA member
