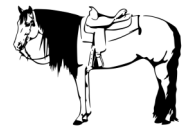

Out-Of-State Horses require 30-Day Health Certificate and Current Coggins
- STALL DETAILS:** Event Center Stalls are 8x10 on Dirt and Expo Hall Stalls are 8x10 on Cement

\$175 Circuit Stall paid after December 23rd
